



## 2011 in review

### Home Care Options

- 384 frail elderly clients were provided personal care in their homes maintaining their independent lifestyle. 243 Traditional Home Care clients & 141 Senior Options clients.
- Home Care provided 46,813.50 units of service: 36,662.75 Traditional Home Care, 10,150.75 Senior Options.

### Family Service Counseling Center of Wood County

- 370 participants attended the Divorce Seminar which provides an eye opening perspective from the children's viewpoint.
- 56 participated in the Domestic Violence Treatment Group.
- 399 clients attained counseling services.

### Four County Family Center

- 1,398 clients attained counseling services.
- 49 on-going adult non-custodial parents received services through It Takes Two Defiance County & 398 teens received a one time presentation.
- 220 adults & 324 youth participated in FAST and FASTWorks programs.
- 1,050 children participated in Incredible Years.
- 19 adult clients serviced through residential group home.

### Family Service of Lucas County

- 782 received individual counseling.
- 341 Police Probation Team participants. 60 Disproportionate Minority Program Participants.
- 247 individuals received services through the Project Genesis program.
- 83 participated in the Batterers Intervention Program.

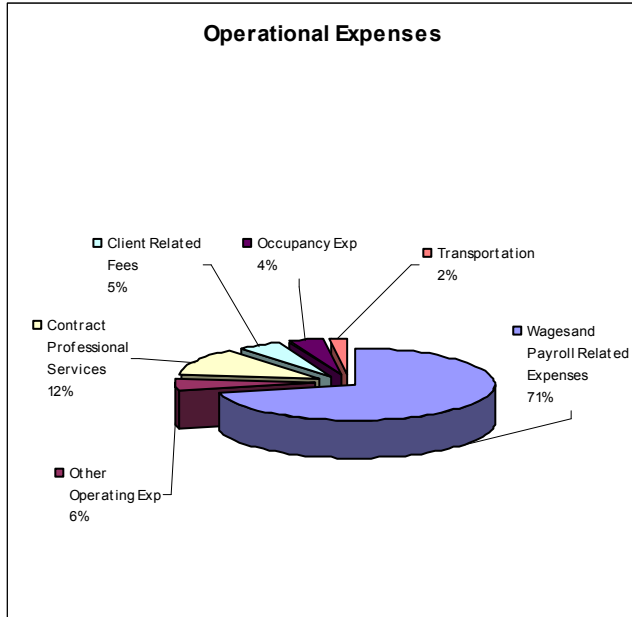

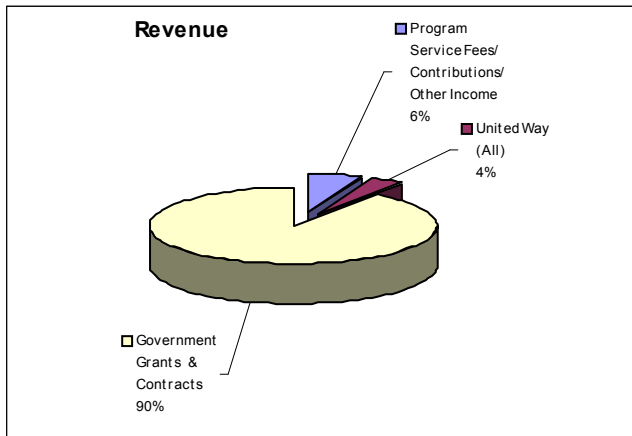
